OP-03 Loan Periods and Fees



POLICY PURPOSE

The North Perth Public Library (NPPL) Board sets guidelines for library service use in accordance with the Public Libraries Act, including fees and fines for services to ensure equitable access for all patrons. The NPPL has been fine free for most materials as of April 4, 2022 - however, some fees and fines still apply.

Charges for collection fees are in alignment with the Perth County Information Network (PCIN) and collective policies. This document outlines what loan rules, and charges continue to exist under these policies.

KEY POINTS SUMMARY

- Fines/Fees will be collected as outlined, where applicable.
- Patron privileges will be suspended when \$10 in fines accumulate.
- When \$50 or more fines/fees have accumulated, patron information will be sent to a third party for recovery.

DEFINITIONS

Fine: a monetary recovery for overdue materials.

Fee: a monetary recovery for a service rendered by the library.

POLICY DETAILS

The following chart outlines where overdue fines still exist and the materials on which they will accumulate.

Ability to borrow materials is suspended when charges exceed \$10 and will be reinstated when all outstanding accounts are settled.

Patron's information will be sent to the 3rd party Unique Management System when fines and/or fees exceed \$50 for collection of fines/fees after 35 days for traditional materials, and 16 days for non-traditional materials.
